COMPLAINT

train, manage, and/or supervise volunteers at the sanctuary which contributed to

Plaintiff's injuries.

As a result, the Plaintiff suffered bodily injury and resulting pain and suffering, 7.

disability, disfigurement, mental anguish, loss of capacity for the enjoyment of life,

expense of hospitalization, medical and nursing care and treatment, loss of earnings,

loss of ability to earn money, and aggravation of a previously existing condition. The

losses are either permanent or continuing and the Plaintiff will suffer the losses in the

future.

WHEREFORE, the Plaintiff, Jennifer M. Lowry, demands judgment for damages against

the Defendant, costs, prejudgment interest, interest and attorney's fees, if applicable, and a trial by

jury.
